

<sup>1</sup>Alpha is a measure of the difference between a portfolio's actual returns and its expected returns, given its level of market risk, which is known as beta. Alpha may be useful in analyzing a manager's ability to add value on a risk adjusted basis to a portfolio's performance. <sup>2</sup>Beta is a means of measuring the volatility of a security in comparison with the market as a whole. A beta of 1 indicates that the security's price will move with the market. A beta of more or less than 1 indicates that the security's price will be more or less volatile, respectively, than the market. <sup>3</sup>Standard Deviation measures the performance volatility of an investment against itself - that is, how much the investment goes up or down. The larger the standard deviation, the more likely the investment may experience a return that is far more or far less than its average.
